**By applying for or renewing a PSKC Membership; you hereby agree to the follow conditions:**

1. You agree to follow the rules, regulations, and policies as outlined in the PSKC Rules, Policies, and Regulations Handbook either written or on special occasions when modified by PSKC.
2. You agree to conduct yourself as sportsman; both on the grounds and while competing in a PSKC event.
3. You agree to accept the final decisions of PSKC, Hunt Director, Judge, Question Panel, or Disciplinary Panel.
4. You agree to release, indemnify and hold harmless ProSport Kennel Club, LLC, its officers, sponsors or anyone working with the organization for any damages, injuries or deaths that occur as a result of your participation in any PSKC event whether arising from negligence of the said releases or otherwise to the fullest extent allowed by law.
5. You agree that should the dog entered in a PSKC event suffer any physical harm while involved in a PSKC competition, or while on the grounds in which the event is held, the handler and owner will hold the Hunt Director, Land Owner, and ProSport Kennel Club, LLC **HARMLESS**.
6. You understand that during the PSKC events, you will be participating on land that may have seen or unseen hazards which can cause injury or even death. You agree to hold harmless and release from liability, the Hunt Director, ProSport Kennel Club, LLC, and the owner of the property for any and all injuries that may be suffered during a PSKC event.
7. You agree that the Hunt Director, Club, and PSKC are not responsible for loss or theft of personal property.
8. You agree to this same release of liability for minor children or anyone else accompanying you at any PSKC event.
9. You agree to give PSKC permission to use your quotes, pictures or videos bearing your likeness to be used in promotional activities by ProSport Kennel Club, LLC without compensation on your behalf.
10. You agree to have read all the rules and further agree to abide by them at any and all functions of ProSport Kennel Club, LLC and understands that not following the rules is entirely your fault and yours alone.
11. You agree that ProSport Kennel Club, LLC reserves the rights and powers to itself and in its discretion and sole judgement, to take action and impose sanctions that would:
  - a. Bar an individual from participating or entering any PSKC Event.
  - b. Bar an individual from registering or transferring any dog or puppy in that person's name (primary or secondary owner) or to any member of that person's family.
  - c. Fine, Suspend or Bar a PSKC Membership
